AMENDMENT AND EXPANSION OF THE BOUNDARIES OF THE DECLARED WATERBERG BONJANALA PRIORITY AREA TO INCLUDE KGETLENGRIVIER LOCAL MUNICIPALITY, MORETELE LOCAL MUNICIPALITY, AND CITY OF TSHWANE METROPOLITAN MUNICIPALITY IN TERMS OF SECTION 18(1) OF THE NATIONAL ENVIRONMENTAL MANAGEMENT: AIR QUALITY ACT 2004, (ACT NO. 39 OF 2004)

I, Dion Travers George, Minister of Forestry, Fisheries and the Environment, hereby publish a notice of my intention to amend and expand the boundaries of the declared Waterberg Bojanala Priority Area to include Kgetlengrivier Local Municipality, Moretele Local Municipality and the City of Tshwane Metropolitan Municipality, in terms of section 18(1) read with sections 56 and 57 of the National Environmental Management: Air Quality Act 2004, (Act No. 39 of 2004).

The Waterberg Bojanala Priority Area was declared by notice in the Government *Gazette* (Government Notice No. 495, Government *Gazette* No. 35435 of 15 June 2012). The areas identified for expansion are categorised in the National Framework for Air Quality Management in the Republic of South Africa (Government Notice No. 1144 Government *Gazette* No. 41996 of 26 October 2018) as areas of concern due to poor air quality, especially elevated levels of particulate matter. A description of the existing and proposed extended boundaries of the Waterberg Bojanala Priority Area is set out in the Schedule attached hereto.

Members of the public are invited to submit written comments within **45 days** from the date of publication of this Notice in the Government *Gazette*, or in newspapers, whichever date is the later date, to the following addresses:
