NOTICE OF INTENTION TO SET A ZERO EXPORT QUOTA FOR TRADE IN LION BONES SOURCED FROM CAPTIVE BREEDING OPERATIONS IN SOUTH AFRICA FOR THE 2025 CALENDAR YEAR IN TERMS OF REGULATION 3(2)(K) AND (F) OF THE CONVENTION ON INTERNATIONAL TRADE IN ENDANGERED SPECIES OF WILD FAUNA AND FLORA REGULATIONS, 2010 (CITES REGULATIONS) AND SECTIONS 99 AND 100 OF THE NATIONAL ENVIRONMENTAL MANAGEMENT: BIODIVERSITY ACT, 2004 (ACT NO. 10 OF 2004)

I, Dion Travers George, Minister of Forestry, Fisheries and the Environment, hereby, in terms of regulation 3(2)(k) and (f) of the Convention on International Trade in Endangered Species of Wild Fauna and Flora Regulations, 2010 (CITES Regulations), published under Government Notice No. R173 in Government Gazette No. 33002 on 5 March 2010, read together with sections 99 and 100 of the National Environmental Management: Biodiversity Act, 2004 (Act No. 10 of 2004), give notice of my intention to set a zero export quota for trade in lion (panthera leo) bones sourced from captive breeding operations in South Africa for the 2025 calendar year.

The intended zero export quota for trade in lion (panthera leo) bones sourced from captive breeding operations in South Africa takes into account, amongst others, the recommendations of the Portfolio Colloquium adopted by the National Assembly in 2018, recommendations of the High Level Panel on the captive lion industry, 2021, and the recommendations of the Ministerial Task Team report on voluntary exit from the captive lion industry, 2024, all of which called for an end to the captive lion breeding industry. The intended zero export quota is informed by Government Policy on captive lion breeding as set out in the White Paper on the Conservation and Sustainable Use of South Africa's Biodiversity, 2023 and the Policy Position on the Conservation and Sustainable Use of Elephant, Lion, Leopard and Rhinoceros, 2024. In particular, the Policy Position provides for the immediate halt of domestication and exploitation of lions, and closure of captive lion facilities.

Members of the public are invited to submit, within 30 days from the date of the publication of this notice in the Government *Gazette* or publication of the newspaper notice, whichever is the last date of publication, written representations on my intention to set a zero export quota for trade in lion (*panthera leo*) bones sourced from captive breeding operations in South Africa for the 2025 calendar year, to any of the following addresses:
