GENERAL NOTICE TO NON-RESPONSIVE ECS/ECNS LICENSEES TO SUBMIT THEIR OUTSTANDING COMPLIANCE DOCUMENTS AND INFORMATION

1. The Independent Authority Communications Authority of South Africa (the "Authority") hereby gives notice, in terms of section 4 (3)(g) of the Independent Communications Authority of South Africa Act, 2000 (Act No. 13 of 2000) as amended, to the licensees listed in **Annexure A** to submit their outstanding compliance documents and information.
2. The Licensees in **Annexure A** have not complied with their compliance obligations, and have not provided their annual compliance submissions that are due in terms of the Compliance Regulations mentioned below in **Table 1**.

3. Note the following:

- 3.1. Where an individual Licensee has not commenced operations, the Licensee must provide the Authority with a letter from external auditors

confirming that it did not generate any revenue from the licensed service.

- 3.2. A Licensee that has not commenced operations and not legally required to have audited financial statements, must submit a letter from an Independent Accounting Officer and a clearance certificate from the South African Revenue Services ("SARS") as proof that it did not generate any revenue from the licensed service.
- 3.3. Where a Licensee no longer operates, a letter to that effect, to enable the Authority to guide the Licensee as to the process to be followed.
4. The required information in terms of paragraphs two (2) and three (3) must be submitted to the Authority **before or on 29 September 2023**, failing which the Authority will refer Licensees to the Complaints and Compliance Committee ("CCC"), for a hearing and adjudication.

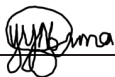
