#### **CORRECTION OF NOTICE PUBLISHED IN GOVERNMENT GAZETTE 3723 OF 07 JANUARY 2026 REGARDING APPLICATIONS RECEIVED IN RESPECT OF THE INVITATION TO PRE-REGISTER FOR COMMUNITY SOUND BROADCASTING SERVICE AND RADIO FREQUENCY SPECTRUM LICENCES**

1. The Independent Communications Authority of South Africa ("the Authority") hereby refers to the Notice published in Government Gazette 3723 of 07 January 2026 regarding applications received pursuant to the Invitation to Pre-register ("ITP-R") published on 10 December 2024.
2. In paragraph [3] of the said Notice, the Authority stated that it had received ninety-one (91) applications, of which forty (40) applications were admitted to Phase 1 of the ITP-R licensing process.
3. The Authority hereby corrects the above-mentioned paragraph to reflect that it received ninety-three (93) applications. Of the ninety-three (93) applications received, forty-one (41) applications were admitted to Phase 1 of the ITP-R licensing process after meeting the necessary requirements, whilst fifty-two (52) applications were disqualified due to non-compliance.
4. Schedule A below contains the details of the one (1) applicant who was not part of the initial gazette. A copy of the redacted version of the application can be accessed on the Authority's website via the following link:

Interested parties are invited to lodge written representations in relation to the applications listed in Schedule A within fourteen (14) working days from the date of publication of this Notice in the Government Gazette. Written representations received after fourteen (14) working day period will not be considered by the Authority.
6. Interested parties who lodge representations must also indicate whether they wish to make oral submissions should the Authority decide to hold public hearings in respect of the applications.
7. Applicants shall be entitled to respond in writing to the written representations made by interested parties in terms of paragraph 5 above, within twenty-eight (28) working days from the date of the publication of the Notice in the Government Gazette. Written responses received after the twenty-eight (28) working days will not be considered by the Authority.
