**NOTICE OF THE PUBLIC HEARING ON THE TRANSITIONAL GENERATION PRICING AND VESTING CONTRACT FRAMEWORK CONSULTATION PAPER**

The National Energy Regulator of South Africa (NERSA) is a regulatory authority established as a juristic person in terms of section 3 of the National Energy Regulator Act, 2004 (Act No. 40 of 2004). NERSA's mandate is to regulate the electricity, piped-gas and petroleum pipelines industries in terms of the Electricity Regulation Act, 2006 (Act No. 4 of 2006), the Gas Act, 2001 (Act No. 48 of 2001) and the Petroleum Pipelines Act, 2003 (Act No. 60 of 2003).

NERSA has developed a consultation paper on the framework for transitional generation pricing and vesting contracts for stakeholder comments. This framework establishes a structured and transitional approach to electricity market reform by separating generation remuneration into distinct economic components aligned with their respective functions.

On 20 May 2026, NERSA published a consultation paper on the framework for transitional generation pricing and vesting contracts. NERSA shall decide on the framework for transitional generation pricing and vesting contracts in terms of the Electricity Regulation Act, 2006, as amended.
