## **DRAFT REGULATIONS:**

## PREVENTION AND COMBATING OF HATE CRIMES AND HATE SPEECH ACT, 2023 (ACT NO. 16 OF 2023)

The Minister of Justice and Constitutional Development has, under—

- (a) section 8(1)(a) and (b) of the Prevention and Combating of Hate Crimes and Hate Speech Act, 2023 (Act No. 16 of 2023), in consultation with the Cabinet member responsible for policing and the National Director of Public Prosecutions; and
- (b) section 10(2)(c) of the Act, in consultation with the Cabinet member responsible for finance, made the Regulations in the Schedule.

#### **Definitions**

- 1. In these Regulations, any word or expression to which a meaning has been assigned in the Act shall bear the meaning so assigned and, unless the context otherwise indicates—
- 'clerk of the court' means a-
- (a) clerk, including an assistant clerk, of the court appointed in terms of section 13; and
- (b) registrar, including an assistant registrar, of a regional division appointed in terms of section 13A,

of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944);

**'complainant'** means the alleged victim of an offence referred to in section 3(2)(a), 4(1)(a) or 4(1)(b) of the Act or a person who reports such offence to the South African Police Service;

'data-base' means any disaggregated statistical information or case management records recorded in a manner that facilitates the collection, analysis, generation and dissemination of information as envisaged by the Act including for monitoring and reporting purposes, in possession of the Director-General whether such information is in electronic format or not;

'Director-General' means the Director-General: Justice and Constitutional Development;

'Registrar of the High Court' means a registrar, including an assistant registrar, of any Division of the High Court appointed in terms of section 11 of the Superior Courts Act, 2013 (Act No. 10 of 2013); and

'the Act' means the Prevention and Combating of Hate Crimes and Hate Speech Act, 2023 (Act No. 16 of 2023).

#### **Duties and functions of Director-General**

- **2.** (1) The Director-General must, subject to regulations 3, 4 and 5, keep a data base as part of the electronic infrastructure of the Department of Justice and Constitutional Development in a manner that facilitates information to be transmitted as contemplated in section 8(1)(a), (b) and (c) of the Act, respectively.
- (2) (a) The information received by the Director-General in terms of regulations 3(2)(b), 4 and 5 must be included in the data base in a manner that enables anonymised statistical data to be generated for purposes of complying with the reporting duties referred to in section 8 of the Act.
  - (b) The Director-General must—

- (i) make the statistical data, referred to in paragraph (a), available on the website of the Department of Justice and Constitutional Development and update the data on a quarterly basis; and
- (ii) within the first two months of each financial year, submit a report to the—
  - (aa) Speaker of the National Assembly and the Chairperson of the National Council of Provinces;
  - (bb) Chairperson of the South African Human Rights Commission;
  - (cc) Chairperson of the Commission for Gender Equality; and
  - (dd) Chairperson of the Commission for the Promotion and Protection of the Rights of Cultural, Religious and Linguistic Communities.

## Information collected by South African Police Service

- **3.** (1) The South African Police Service must, when an alleged offence of a hate crime or hate speech is reported by a victim, record the information, in the case of the alleged commission of—
- (a) an underlying offence as a hate crime referred to in section 3(2)(a);
- (b) hate speech referred to in section 4(1)(a); or
- (c) an offence referred to in section 4(1)(b),

of the Act, in a form that corresponds substantially with Form 1, 2 or 3 in the Annexure, respectively.

- (2) (a) The Station Commander of each police station must, every six months, submit a report in a form that substantially corresponds with Form 4 in the Annexure to the Provincial Commissioner concerned.
- (b) The Provincial Commissioners must, at the end of each financial year, submit consolidated reports in a form that corresponds substantially with Form 5 in the Annexure to the National Commissioner of the South African Police Service and the Director-General.

### Information collected by Directors of Public Prosecutions

**4.** The Directors of Public Prosecutions or the persons delegated thereto by them, as provided for in terms of sections 3(3) and 4(3) of the Act, must, at the end of each financial year, submit reports in a form that corresponds substantially with Form 6 in the Annexure to the National Director of Public Prosecutions and the Director-General.

## Information collected by clerks of court and Registrars of High Court

- **5.** (1) When a court convicts a person of an—
- (a) underlying offence as a hate crime referred to in section 3(2)(a);
- (b) offence of hate speech referred to in section 4(1)(a); or
- (c) offence referred to in section 4(1)(b),
- of the Act, the clerk of the court or the Registrar of the High Court must immediately submit reports in a form that substantially corresponds with Form 7, respectively, to the Director-General.
- (2) When a conviction referred to in subregulation (1) is taken on review or appeal the Registrar of the High Court must submit a report in a form that corresponds substantially with Form 7 to the Director-General.

### **Short title**

**6.** These Regulations are called the Prevention and Combating of Hate Crimes and Hate Speech Regulations.
