#### TERMINATION NOTICE

#### **INVESTIGATION INTO THE ALLEGED CIRCUMVENTION OF THE ANTI-DUMPING DUTIES ON NEW PNEUMATIC TYRES OF RUBBER OF A KIND USED ON MOTOR CARS (CLASSIFIABLE UNDER TARIFF SUBHEADINGS 4011.10.01, 4011.10.03, 4011.10.05, 4011.10.07, AND 4011.10.09) AND ON BUSES OR LORRIES (CLASSIFIABLE UNDER TARIFF SUBHEADINGS 4011.20.16, 4011.20.18, AND 4011.20.26) THROUGH COUNTRY HOPPING FROM THE PEOPLE'S REPUBLIC OF CHINA VIA THE KINGDOM OF CAMBODIA, THE KINGDOM OF THAILAND, AND THE SOCIALIST REPUBLIC OF VIETNAM**

The International Trade Administration Commission of South Africa ("the Commission") hereby gives notice of the termination of the anti-circumvention investigation into the alleged circumvention of the anti-dumping duties on new pneumatic tyres of rubber of a kind used on motor cars, and on buses or lorries, through country hopping from the People's Republic of China ("PRC") via the Kingdom of Cambodia ("Cambodia"), the Kingdom of Thailand ("Thailand"), and the Socialist Republic of Vietnam ("Vietnam").

#### **REASONS FOR TERMINATION**

The Minister of Trade, Industry and Commission ("the Minister") did not approve the Commission's recommendation and instead directed that the matter be referred back. Given that the 18-month period prescribed for the completion of an anti-circumvention review in terms of South Africa's Anti-Dumping Regulations (ADR) has since lapsed, the Minister further directed that the process be initiated afresh. The detailed reasons of the Minister's considered decision will be published together with the Commission's Final Determination.

The Commission is therefore precluded, in terms of the Anti-Dumping Regulations, from continuing with the investigation or imposing anti-dumping duties in respect of the subject product.

#### **TERMINATION EFFECTIVE DATE**

This termination takes effect immediately from the date of publication of this notice, and the investigation is hereby terminated.

#### **IMPLICATIONS OF TERMINATION**

As a result of the termination of this investigation, no anti-circumvention duties will be imposed on imports of on new pneumatic tyres of rubber of a kind used on motor cars, and on buses or lorries, through country hopping from the PRC via Cambodia, Thailand and Vietnam.
