#### **SCHEDULE**

#### **Definitions**

- 1. In these regulations-
  - "the Act" means the Medicines and Related Substances Act, 1965 (Act 101 of 1965); and
  - "the Regulations" means the General Regulations as published under Government Notice 859 in *Government Gazette* 41064 of 25 August 2017.

## Amendment of Regulation 10 of the Regulations

- Regulation 10 of the Regulations is hereby amended by the substitution for sub-paragraph (1)(cc)(iv) of the following sub-paragraph:
  - "(iv) containing at least 5 percent of <u>genetically</u> modified organisms the following warning "contains genetically modified organisms"."

## Amendment of Regulation 11 of the Regulations

- 3. Regulation 11 of the Regulations is hereby amended by the substitution for paragraph (1)(d) of the following paragraph:
  - "(d) **[under the headings and]** shall contain the particulars specified in subregulation (2) under the headings as determined by the Authority."

### Amendment of Annexure 1 of the regulations

- **4.** Annexure 1 of the Regulations is hereby amended by the substitution for Class 33.3 of the following Class:
  - "33.3 [Phytotherapy] Ayurveda"

### Amendment of Annexure 2 of the regulations

- **5.** Annexure 2 of the Regulations is hereby amended by the substitution for Class 28.3 of the following Class:
  - "28.3 [Phytotherapy] Ayurveda"
