NOTICE IN TERMS OF REGULATION 2(4) OF THE NORTH WEST LAND TRANSPORT REGULATIONS, 2021, MADE IN TERMS OF SECTION 10 OF THE NATIONAL LAND TRANSPORT ACT, 2009: INVITATION FOR PUBLIC COMMENTS

1. 
