## NOTICE 2420 OF 2024



#### Notice of the second set of National Nuclear Regulator (NNR) public hearings for the application to extend the operating life of the Koeberg Nuclear Power Station (KNPS) by 20 years.

The NNR is an independent regulatory authority established as a juristic person in terms of section 3 of the National Nuclear Regulator Act (Act No.47 of 1999) (NNRA). The NNR ensures the effective oversight of nuclear and radiation safety to protect people and the environment from the risks of radiation associated with nuclear power plants, nuclear technology, radioactive waste and naturally occurring radioactive materials. The authority vested in the NNR is enshrined in national legislation, which gives it the power to exercise regulatory control related to safety over siting, design, construction, operation, manufacture of component parts, and decontamination, decommissioning, and closure of nuclear installations. As part of the NNR's public participation process in accordance with section 21(4) of the NNRA, the Board held the first set of public hearings in Cape Town on 3,10 and 17 February 2024. The objective was to gather information from various stakeholders and members of the public on their concerns relating to health, safety and environment connected with the Koeberg LTO application.

The NNR Board will be conducting a second set of public hearings to ensure that sufficient information is gathered to complete the final review process of the Koeberg LTO application. Members of the public and all stakeholders are invited to attend the second set of scheduled public hearings for the Koeberg LTO application.

The hearings will be conducted in the Northern Cape and Western Cape provinces of South Africa as indicated in the following schedule:
