INVITATION TO COMMENT:

REQUEST FOR PUBLIC COMMENT ON SAQA'S INTENTION TO RECOGNISE NEW PROFESSIONAL BODIES, REGISTER PROFESSIONAL DESIGNATIONS AND NOTIFICATION OF WITHDRAWAL OF SAQA RECOGNITION

In accordance with the *National Qualifications Framework Act, 2008* (Act No. 67 of 2008) and the South African Qualifications Authority's (SAQA) *Policy and Criteria for Recognising a Professional Body and Registering a Professional Designation for the Purposes of the National Qualifications Framework Act, Act 67 of 2008 (As amended, September 2020)* referred to as the *P&C for professional bodies*, SAQA invites comment from interested parties on SAQA's intention to recognise new professional bodies and register additional professional designations.

1. Recognition of New Professional Bodies

- 1.1 The public is kindly invited to comment on SAQA's intention to recognise the South African Career Development Association (SACDA) and to register its one designation title namely:
 - (a) Career Development Practitioner – Career Information (CDP-CI)
- 1.2 The public is kindly invited to comment on SAQA's intention to recognise the Institute of Loss Adjusters of Southern Africa (ILASA) and to register its three professional designation titles namely:
 - (a) Licentiate Loss Adjuster - LILA
 - (b) Associate Loss Adjuster – AILA
 - (c) Fellow Loss Adjuster - FILA

2. Registration of Additional Designations

The public is invited to comment on SAQA's intention to register additional designations for the Professional Body listed below:

 - (b) Professional Business Advisor (SA) – PBA (SA)
 - (c) Professional Business Advisor Specialist (SA) – PBAS (SA)
- 2.2 Institute for Work at Height (IWH)
One additional professional designation title
 - (a) Certified Work at Height Master Professional
- 2.3 Compliance Institute Southern Africa (CISA)
One additional professional designation title
 - (a) Anti-Financial Crime Practitioner (SA) / AFC Prac (SA)

2.4 Southern African Institute of Government Auditors (SAIGA)

One additional professional designation title

(a) Certified Performance Audit Specialist

3. Notification of withdrawal of recognition of a recognised Professional Body

In accordance with the *National Qualifications Framework Act, 2008* (Act No. 67 of 2008) and in accordance with Clause 22. a. of the *P&C for professional bodies*, SAQA may withdraw the recognition status from a professional body if the body no longer complies with the *P&C for professional bodies*.

Institute of Certified Bookkeepers and Accountants (ICBA), a non-statutory professional body, was recognised by SAQA with effect from 20 May 2015.

On 7 December 2021, SAQA received a request from ICBA to withdraw its recognition status and de-register its designations from the National Qualifications Framework (NQF).

On 10 February 2022, SAQA's Professional Bodies Committee withdrew the recognition status of ICBA and de-registered its professional designations from the NQF.

The withdrawal of recognition of the Professional Body:

- CSOA-ICBA(SA) - Certified Senior Office Administrator
- COM-ICSA(SA) - Certified Office Manager
- CSBFM-ICBA(SA) - Certified Small Business Financial Manager
