PROCLAMATION NOTICE 335 OF 2026

PUBLIC NOTICE: URGENT ACTION REQUIRED

IN ACCORDANCE WITH SECTION 3 OF THE PROMOTION OF ADMINISTRATIVE JUSTICE ACT, 2000 (ACT NO. 3 OF 2000) READ WITH THE PROVISION OF SECTION 79 OF THE NATIONAL ROAD TRAFFIC ACT, 1993 (ACT NO. 93 OF 1996)

OF

INTENTION TO VERIFY AND CANCEL UNVERIFIED DORMANT TRAFFIC REGISTER NUMBER CERTIFICATES ISSUED IN THE PERIOD 1 JANUARY 2000 TO 30 JUNE 2023 UNDER REGULATION 335 OF THE NATIONAL ROAD TRAFFIC ACT, 1993 (ACT NO. 93 OF 1996)

The Department of Transport ("the Department") hereby notifies the public:

1. Section 79 of the National Road Traffic Act, 1996 (Act No. 93 of 1996) (NRTA) provides amongst others that the Minister of Transport (Minister) may, in exercising a discretion or taking a decision in terms of this Act, take cognisance of the information contained in National Traffic Information System (NaTIS), the official register of a Traffic Register Number (TRN) issued in terms of Regulation 335 of the NRTA.
2. A comprehensive joint verification exercise conducted by the Department and the Department of Home Affairs confirmed that certain TRNs issued in the period 1 January 2000 to 30 June 2023 are dormant.
3. The Minister, in consultation with all relevant provincial Members of the Executive Council, has determined that TRNs issued in the mentioned period, that appear to be dormant, unless confirmed active as per the process set out in this notice, will be cancelled 30 days from date of publication of this Notice.
4. **TRN HOLDERS WHO ARE REQUIRED TO VERIFY**
 - 4.1 Natural persons who obtained their TRN in the period 1 January 2000 to 30 June 2023.
5. In initiating this process the Department will be publishing a list of TRNs for natural persons identified as dormant.
6. The list is made available for public access on the Department's official website: <https://www.transport.gov.za>, which also provide a portal that TRN holders who obtained their TRNs between 1 January 2000 and 30 June 2023 can use to query of their TRN appears on the list of dormant records.

7. PROCESS FOR VERIFICATION:

- 7.1 Holders of the TRNs in the dormant list as published on the website are hereby called upon to within 30 (Thirty) working days from the date of publication of this notice, submit representation at the following Provincial Department of Transport sites:

8. WHAT TO DO WHEN YOUR TRN APPEARS TO BE DORMANT

8.1 TRN Holders who via the website learned that their TRN are on the dormant list have the option submit representation to the sites listed in 7.1. Representation must include:

- 8.1.1 Temporary Identity Certificate or valid South African Identity document
- 8.1.2 Unexpired Passport; or
- 8.1.3 Temporary permit; or
- 8.1.4 Any other document of identity of a class recognised by the Minister of Home Affairs in terms of the legislation regulating the admission of persons to the Republic of South Africa; and
- 8.1.5 Two photographs; and
- 8.1.6 Proof of residential address

9. EXPECT AN OUTCOME

9.1 TRN holders that submitted the required information and or documents for verification can check the outcome of their submission within 90 (ninety) days from the date of submission of information and documents.

10. DEADLINE: CANCELLATION OF TRN

10.1 Dormant TRNs on which no representation was received within 30 (thirty) working days from date of publication of this Notice or upon the expiry of the representations period, shall be formally cancelled on the NaTIS as the official register.
