BACKGROUND

The South African Council for the Project and Construction Management Professions (SACPCMP) appointed Enterprises University of Pretoria (Pty) Ltd (Enterprises UP) to rebase the current fees of Registered Construction Health and Safety Professionals for **PROFESSIONAL HEALTH & SAFETY AGENTS** to be effective for 2022. This provides the methodology and assumptions used to rebase the existing Guideline Tariff of Fees to 2022.

2019 Fees

The most recently gazetted fees were published in 2019 in Board Notice 167 of 2019 titled SACPCMP Guideline Scope of Services and Recommended Guideline Tariff of Fees for Construction Health and Safety Professionals Registered in terms of the Project and Construction Management Professions Act, 2000 (Act No. 48 of 2000). The table below is taken from the above-mentioned gazetted board notice as the 2019 fees in respect of normal services in the field of Construction Health and Safety Agent, pertaining to building projects. The fees and project costs shown below are exclusive of Value Added Tax ('VAT').

^{*}The "Cost of the works" in the above table is defined as the total amount, inclusive of the value of free issue items, exclusive of value added tax, certified or for which would be certified for payment to contractors (irrespective of who actually carries out the works) in respect of the works in respect of which the Construction Health and Safety Agent is performing a construction health and safety service, before deduction of liquidated damages or penalties.

Methodology and Assumptions

In order to increase the rates from 2019 to 2021, the following were considered:

- The increase in project costs from 2019 to 2021
- The increase in construction health and safety service fees from 2019 to 2021.

Project costs were assumed to increase by Consumer Price Inflation ('CPI'), as published by Statistics South Africa ('StatsSA'). CPI represents the overall increase in price levels across the economy. Therefore, CPI is the most appropriate inflationary measure to estimate the general increase in project costs. Construction health and safety service fees were assumed to increase by a sub-component of CPI, specifically, CPI for services, as published by 'StatsSA'. This is the most appropriate measure when estimating the inflationary adjustment required for construction health and safety services as it is specific to the price level increases that are applicable to the services sector of the economy. Delineating cost adjustments based on both CPI and CPI for services enables a more accurate and realistic portrayal of the actual price and cost adjustments for both project costs and project management services. CPI was selected as the most appropriate inflationary measure for this fee escalation as this index is a more general inflationary index that encompasses price fluctuations with regard to project costs and project management service fees. A comparison between CPI, PPI and the BER¹ Building Cost Index was undertaken. The table below shows this comparison and reveals that there were no material differences between the escalation rates between CPI, PPI and the BER Index for 2019 and 2020. For 2019, CPI was 0.6 percentage points below PPI and 0.4 percentage points below the BER Index. Conversely, in 2020, CPI was 0.6 percentage points higher than PPI and 0.2 percentage points higher than the BER Index. All the considered indexes will therefore result in similar 2021 tariffs.

The 2021 rates were therefore set in such a way that the average fees earned per project would be expected to increase by CPI for services, if it is assumed that project costs increased by CPI.

The following inflation indices were applied in the rebasing calculations of the 2022 tariff fees.

The total CPI increase over the two-year period is 7.22% (117.3 divided by 109.4). This increase was applied to the cost of works values in the fee table, with values rounded to the nearest R100,000. The total CPI for services increases over the two-year period is 7.95% (119.5 divided by 110.7). The Add %'s in the fee table were adjusted such that the expected total fee payable at the top end of each project cost bracket (and R5.490 billion on the top bracket, which is the bottom end of the top bracket plus double the difference between the top end and the bottom end of the second highest bracket) would increase by approximately 7.95% (ie the CPI services increase). These percentages were rounded to the nearest 0.01%.

The Primary Fees in the fee table were set based on the Add % as calculated above to ensure that the fees are smooth between brackets, with values rounded to the nearest Rand. We have developed a simple Microsoft Excel Based model to calculate the 2021 fees, based on the following inputs:

- 2019 fee structure
- The increase in project costs from 2019 to 2021
- The increase in project management service fees from 2019 to 2021
- Rounding criteria.

The 2021 fee update based on the above inputs and methodology described in this document

The table below provides the 2021 fees in respect of construction health and safety agent services pertaining to building projects, based on the methodology, assumptions and 2019 Tariff of Fees guideline, described in the sections above.
