Section 5(2)(j)	One person from each data custodian as identified by the Minister	

CALL FOR NOMINATIONS TO FILL VACANCIES IN THE COMMITTEE FOR SPATIAL INFORMATION

Members of the Committee will be required to provide strategic direction in the development and implementation of the South African Spatial Data Infrastructure (SASDI), to address matters relating to spatial information and to ensure that government investment in spatial information yields maximum benefit.

Nominations must be submitted by completing and returning Form B and Form C, as prescribed in the Regulations of the Act, attached hereto as Annexure A. Nominations must be accompanied by a written acceptance of the nomination by the candidate; a comprehensive curriculum vitae and copies of qualifications of the person nominated.

Nominated candidates must be South African citizens with appropriate qualifications and demonstrable expertise in Geographic Information Science.

Persons nominated must not be disqualified in terms of Section 8 of the Spatial Data Infrastructure Act, 2003 (Act No. 54 of 2003) and all nominated individuals must declare compliance with the requirements stipulated in Regulation 11(b) of the Spatial Data Infrastructure Regulations.

Appointed members will serve for the unexpired term of the current Committee, with appointments taking effect immediately upon approval by the Minister.
