SANS 1104 Ed 1	<i>Gas vehicle propulsion system. Standard covers the safe use of compressed natural gas as fuel for internal combustion engines and for the safe operation of equipment manufactured for conversions.</i>	2019-08-18

SATS 22002-6:2019 Ed 1	<i>Prerequisite programmes on food safety - Part 6: Feed and animal food production.</i> Specifies requirements for establishing, implementing and maintaining prerequisite programmes (PRPs) to assist in controlling feed safety hazards in feed and animal food and in materials intended for use in the production of feed and animal food, specifically feed safety hazard attributes that have a potential to affect animal and/or human health adversely.
SANS 457-3:2019 Ed 8	<i>Wooden poles, droppers and guardrail posts - Part 3: Hardwood species.</i> Specifies requirements for preservative-treated hardwood structural poles, agricultural poles, fencing poles, round droppers, guardrail posts and spacer blocks.
SANS 20013:2019 Ed 4	<i>Uniform provisions concerning the approval of vehicles of categories M, N and O with regard to braking.</i> Applies to vehicles of categories M2, M3, N and O with regard to braking.
SANS 10007:2019 Ed 2	<i>Quality management systems - Guidelines for configuration management.</i> Gives guidance on the use of configuration management within an organization.
