SANS 20113:2019 Ed 1	<i>Uniform provisions concerning the approval of motor vehicle headlamps emitting a symmetrical passing beam or a driving beam or both and equipped with filament, gas-discharge light sources or LED modules.</i> Applies to headlamps for vehicles of categories L and T3.
SANS 60623:2019 Ed 2	<i>Secondary cells and batteries containing alkaline or other non-acid electrolytes - Vented nickel-cadmium prismatic rechargeable single cells.</i> Specifies marking, designation, dimensions, tests and requirements for vented nickel-cadmium prismatic secondary single cells.
SANS 61482-2:2019 Ed 1	<i>Live working - Protective clothing against the thermal hazards of an electric arc - Part 2: Requirements.</i> Applies to protective clothing used in work where there is the risk of exposure to an electric arc hazard.
SANS 18295-2:2019 Ed 1	<i>Customer Contact Centres - Requirements for using the services of Customer Contact Centres.</i> Specifies requirements for organizations using the services of customer contact centres (CCC).
SANS 60598-2-17:2019 Ed 2	<i>Luminaires Part 2: Particular requirements Section 17: Luminaires for stage lighting, television, film and photographic studios (outdoor and indoor).</i> Specifies requirements for stage, television, film and photographic studio luminaires (including spot and floodlighting projectors) for use outdoors and indoors, with electric light sources on supply voltages not exceeding 1 000 V.
