SANS 20130:2023 Ed 1	<i>Uniform provisions concerning the approval of motor vehicles with regard to the Lane Departure Warning System (LDWS).</i> Applies to the lane departure warning system of vehicles of categories M2, N2, M3 and N3 1.
SANS 20131:2023 Ed 1	<i>Uniform provisions concerning the approval of motor vehicles with regard to the Advanced Emergency Braking Systems (AEBS).</i> Applies to the approval of vehicles of category M2, N2, M3 and N3 1 with regard to an on-board system to avoid or mitigate the severity of a rear-end in lane collision.
SANS 10460:2023 Ed 3	<i>Gas cylinders – Welded aluminium-alloy, carbon and steel gas cylinders – Periodic inspection and testing.</i> Specifies the requirements for the periodic inspection and testing of welded aluminium-alloy, carbon and stainless-steel gas cylinders of water capacity from 0,5 l to 150 l intended for compressed and liquefied gas service under pressure and to verify the integrity of such gas cylinders for further service.
SANS 20014:2023 Ed 3	<i>Uniform provisions concerning the approval of vehicles with regard to safety-belt anchorages, ISOFIX anchorages systems and ISOFIX top tether anchorages.</i> Applies to anchorages for safety-belts intended for adult occupants of forward-facing or rearward-facing seats in vehicles of categories M and N.
