STANDARDS MATTERS

In terms of the Standards Act, 2008 (Act No. 8 of 2008), the Board of the South African Bureau of Standards has acted in regard to standards in the manner set out in the Schedules to this notice.

SANS 60670-24:XXXX Ed 3	<i>Boxes and enclosures for electrical accessories for household and similar fixed electrical installations Part 24: Particular requirements for enclosures for housing protective devices and other power dissipating electrical equipment.</i> This standard applies to enclosures and parts of them for housing protective devices and other power dissipating electrical equipment intended to be used with a rated voltage not exceeding 400 V and a total incoming load current not exceeding 125 A for household and similar fixed electrical installations.	25-09-2025
SANS 60884-2-2:XXXX Ed 3	<i>Plugs and socket-outlets for household and similar purposes Part 2-2: Particular requirements for socket-outlets for appliances.</i> This standard applies to socket-outlets for a.c. only, with or without earthing contact, with a rated voltage not exceeding 250 V and a rated current not exceeding 16 A, which are integrated or intended to be incorporated in or fixed to appliances.	25-09-2025
SATR 62898-4:20XX Ed 1	<i>Microgrids -Part 4: Use cases.</i> This standard describes business use cases (high-level use cases covering the main typical usage of microgrids) and details some of them. System use cases linked to those business use cases are listed and briefly described for contextualizing the main functions to be performed for managing microgrids. Ultimately, the goal of this document is to provide a consistent level of detail for all business use cases. The document details the methodology retained to develop system use cases from the business use cases.	25-09-2025
SANS 60364-4-42:20xx Ed 1	<i>Low-voltage electrical installations - Part 4-42: Protection for safety - Protection against thermal effects.</i> This standard applies to electrical installations with regard to measures for the protection of persons, livestock and property against: • thermal effects, risk of combustion or degradation of materials, and risk of burns caused by electrical equipment, • flames in case of a fire hazard being propagated from electrical installations to other fire compartments segregated by barriers which are in the vicinity, and • the impairment of the safe functioning of electrical equipment, including safety services due to thermal effects.	25-09-2025
SANS 60364-4-41:20xx Edition 1 and amendment 1	<i>Low voltage electrical installations - Part 4-41: Protection for safety - Protection against electric shock.</i> This standard specifies essential requirements regarding protection against electric shock of persons and livestock.	25-09-2025
SANS 60364-4-43:20xx Ed 1	<i>Low-voltage electrical installations - Part 4-43: Protection for safety - Protection against overcurrent.</i> This standard provides requirements for: - protection of live conductors, PEN conductors, PEM conductors, and PEL conductors against the harmful effects caused by overcurrent; - coordination of measures for protection against overcurrent.	25-09-2025
SANS 4136:20XX Ed 3	<i>Destructive tests on welds in metallic materials - Transverse tensile test.</i> This standard specifies the sizes of test specimen and the procedure for carrying out transverse tensile tests to determine the tensile strength and the location of fracture of a welded butt joint. This document applies to metallic materials in all forms of product with joints made by any welded butt joint.	25-09-2025
SANS 15589-1:20XX Ed 2	<i>Petroleum, petrochemical and natural gas industries - Cathodic protection of pipeline systems Part 1: On-land pipelines.</i> This standard specifies requirements and gives recommendations for the pre-installation surveys, design, materials,	25-09-2025

	equipment, installation, commissioning, operation, inspection, and maintenance of cathodic protection systems for on-land pipelines, as defined in ISO 13623 or EN 14161 for the petroleum, petrochemical, and natural gas industries, and in EN 1594 or EN 12007-1 and EN 12007-3 used by gas supply industries in Europe.	
SANS 2341: XXXXX Ed 1	<i>Essential oil of Lippia Javanica</i> . This standard applies to essential oil of Lippia javanica.	25-09-2025
SANS 19116: 20xx Ed 2	<i>Geographic information - Positioning services</i> . This standard specifies the data structure and content of an interface that permits communication between position-providing device(s) and position-using device(s) so that the position-using device(s) can obtain and unambiguously interpret position information and determine whether the results meet the requirements of the use.	25-09-2025
SANS 19144-2:20xx Ed 2	<i>Geographic information- Classification systems - Part 2 Land cover Meta Language (LCML)</i> . This standard specifies a Land Cover Meta Language (LCML) expressed as a UML metamodel that allows different land cover classification systems to be described based on the physiognomic aspects.	25-09-2025
SANS 18000-4:20xx Ed 3	<i>Information technology - Radio frequency identification for item management Part 4: Parameters for air interface communications at 2,45 GHz</i> . This standard defines the air interface for radio frequency identification (RFID) devices operating in the 2,45 GHz industrial, scientific, and medical (ISM) band used in item management applications.	25-09-2025
SANS 19115-2:20xx Ed 2	<i>Geographic information - Metadata Part 2: Extensions for acquisition and processing</i> . This standard provides information on the properties of the measuring equipment used to acquire the data, the geometry of the measuring process employed by the equipment, and the production process used to digitize the raw data.	25-09-2025
SANS 31031: XXXX Ed 1	<i>Managing risk for youth and school trips</i> . This standard gives guidance on managing risk for youth and school trips for both domestic and international travel with specific attention to minors.	25-09-2025
SANS 754: XXXX Ed 7	<i>Eucalyptus poles, cross-arms and spacers for power distribution and communications systems</i> . This standard specifies the requirements for eucalyptus poles, grown in Southern Africa, and that are intended to be used as upright supports for communications systems, and as upright supports, cross-arms and spacers (in five-pole structures) for power distribution lines.	25-09-2025
SANS 15589-2: 20xx Ed 2	<i>Oil and gas industries including lower carbon energy - Cathodic protection of pipeline transportation systems Part 2: Offshore pipelines</i> . This standard specifies requirements and gives recommendations for the pre-installation surveys, design, materials, equipment, fabrication, installation, commissioning, operation, inspection and maintenance of cathodic protection (CP) systems for offshore pipelines for the petroleum, petrochemical and natural gas industries as defined in ISO 13623.	25-09-2025
SANS 60670-1:XXXX Ed 3	<i>Boxes and enclosures for electrical accessories for household and similar fixed electrical installations Part 1: General requirements</i> . This standard applies to boxes, enclosures and parts of enclosures (hereafter called "boxes" and "enclosures") for electrical accessories with a rated voltage not exceeding 1 000 V AC and 1 500 V DC intended for household or similar fixed electrical installations, either indoors or outdoors.	25-09-2025
SATS 62271-320:20XX Ed 1	<i>High-voltage switchgear and controlgear - Part 320: Environmental aspects and life cycle assessment rules for high-voltage switchgear and controlgear</i> . This standard provides guidance to suppliers, manufacturers, users, and waste operators of high-voltage switchgear and controlgear as well as their assemblies having a rated voltage above 1 kV AC and 1,5 kV DC, together with their associated auxiliary equipment, on environmentally conscious design, and on assessing environmental impacts when used in systems.	25-09-2025
